NOTICE OF RACE

1. ORGANIZING AUTHORITY:

The Lake Lanier Sailing Club (LLSC) Auxiliary Fleet is the organizing authority for this regatta.

2. RULES:

The races will be governed by the Rules as defined in the current Racing Rules of Sailing.

3. ELIGIBILITY:

The regatta is open to all auxiliary boats. All boats must have a current LLPHRF rating certificate on file with the LLPHRF. If required, ratings will be assigned during the registration period by a LLPHRF representative at a cost of \$8.00 for the rating certificate.

4. CLASSES:

Classes **may** include: sport boat, spinnaker and non-spinnaker (high, medium, and low). PHRF fleets will be split by PHRF handicap ratings based upon the boats registered in the Regatta. A minimum of five boats will constitute a class.

5. SAILING INSTRUCTIONS:

Sailing Instructions (SI's) will be distributed at the LLSC clubhouse during registration.

6. SCORING:

The low point scoring system using the standard time on distance corrected time formula (based on current LLPHRF ratings) will apply. All races will be scored.

7. COURSES:

Courses will be defined in the SI's.

8. NUMBER OF RACES:

Depending on conditions, more than one race may be started. No races will start after 15:00.

9. TROPHIES:

Trophies based upon fleet size will be awarded after completion of the last race.

10. ENTRIES AND FEES:

On site registration will be available at the LLSC clubhouse on February 4, 2012 at 09:00. The Entry Fee is \$15.00.

11. SKIPPERS MEETING:

A Skippers Meeting will be held at the LLSC clubhouse, 09:00 Saturday, February 4, 2012.
